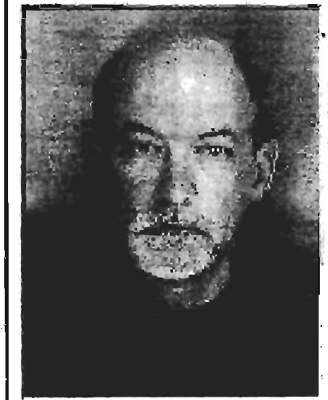

Report Narrative

HISTORY:

I have an undercover online persona of a single parent of two minor children, a 3 year old boy and a 5 year old girl. This online persona has online profiles that have interests groups that depict and interest in sexual activities with children and incest. My persona also has profiles on social networking websites were the profile pages indicate that the persona is interested in incest.

ORIGIN:

I had received a request to add on to my buddy list via Yahoo profile from a subject with a Yahoo screen name fldaddy04 (John Davidson). On 8-29-07, at approximately 1320 hours I was sent an offline message from that subject. He stated he was "interested in chatting", was a "family man" and had "lots of real experience".

INVESTIGATION:

On 8-31-07, during instant message conversation the subject asked about my family's experience. The subject indicated he had two grown daughters that he had molested and had been with other children as well that were ages 7, 8, and 12. The subject indicated he he had traveled in the past to meet up with children for sex and indicated a preference in anal sex with them.

The online chats with the subject continued over the course of several days. During the chats the subject indicated he was interested in traveling to Michigan to meet my 5 year old daughter for the purpose of oral sex and sexual intercourse, particularly anal sex. The subject stated he would bring the girl presents such as earrings, stuffed animals and a Dora dress-up doll. He indicated he wanted these meetings to be frequent and stated on future visits he would bring more clothes for the dress-up doll. During the online investigation the subject stated he would help me with ways to have the child keep the sexual activity a secret. The subject also recommended "Vaseline" be used for a lubricant and stated he would provide that.

On 9-4-07, during instant message conversation the subject booked a flight to Detroit for a travel date of 9-16-07. During this conversation the subject booked an additional flight for a return visit on 10-7-07.

I notified S/A Matthew A. Bowman of the Macomb RA FBI Office of the investigation and possible travel dates. In response to grand jury subpoenas S/A Bowman identified the subject as John David Roy Atchison of Pensacola Florida. S/A Bowman confirmed Atchison's flight for 9-16-07. The

investigation was turned over to the FBI but it was determined that I would continue chatting with the subject until his flight arrival.

ARREST:

On 9-16-07 at approximately 1700 hours, S/A Bowman arrested Atchison at Detroit Metro Airport as he exited the plane. D/Sgt. Old, S/A Matthew A. Bowman and I then transported the subject to the Macomb RA for processing.

INTERVIEW:

During the transportation S/A Bowman read Atchison Miranda verbatim. Atchison stated he understood and was willing to answer questions. Atchison stated that he has never molested any children in his life and that he was only traveling up here to "talk the mother out of it". He stated that he did bring the child earrings, a Dora doll and a stuffed animal, but was going to show the child she could get presents without anything sexual happening. The subject further stated that he did bring Vaseline but he used that specifically for his lips and was not going to use it as a lubricant. The subject also had a "Cialis" pill (erectile dysfunction) in his right front pocket. He stated he did not remember how it got into his pocket.

DISPOSITION:

Atchison was processed at the Macomb RA.

Atchison's carry-on luggage and laptop computer were seized by S/A Bowman.

Deputy Zielger responded to the RA and transported Atchison to the Macomb County Jail to be held overnight.

On 9-17-07, S/A Bowman and D/Sgt. Old transported Atchison to the US Marshall's in Detroit.
